ADDENDUM NO. 1

To

Provision of Pre verification of Conformity (PVoC) to standards for used motor vehicles on behalf of BBSQ

This Addendum No. 1 to the contract for the provision of PVoC to standards for used motor vehicles on behalf of BBSQ is entered into this 28 February 2020 between:

The Government of The Commonwealth of The Bahamas as represented by the Ministry of Labour and implemented through The Bahamas Bureau of Standards and Quality (BBSQ), a standards body established by The Standards Act, Chapter 338A of the Laws of The Bahamas, and having its principal place of business at The Source River Ctr. 1000, Bacardi Road, Nassau, The Bahamas

And

EAA Company Limited, having its principal place of business at Nakat Building, 1-10-5-101 Rinkan, Yamato-Shi, Kanagawa-Ken, Japan

WHEREAS

- a) The contract for services was due for completion on the 29th Day of February 2020.
- b) There has been mutual agreement to extend the existing contract for a further 3 years (ending 28 February 2023).
- c) There has been mutual agreement for an increase in per unit Administration fees paid to BBSQ.

Now therefore the parties hereto hereby agree as follows:

1. Clause GCC 1.1(e) of the Special Conditions of the Contract is amended by deleting the passage "*An administration fee of \$20.00 per unit to be paid to BBSQ*", and replacing the same with the following:

"An administration fee of \$40.00 per unit to be paid to BBSQ"

2. Clause GCC 2.3 of the Special Conditions of the Contract is amended by deleting the passage "*The intended completion date is: 1 year after commencement date*", and replacing the same with the following:

"The intended completion date is 28th February 2023"

3. Clause GCC 6.1 of the Special Conditions of the Contract is amended by deleting the passage "*The agreed inspection fee (which is made up of the cost for conducting the inspection and a BBSQ administrative fee per unit of US\$20)*", and replacing the same with the following:

"The agreed inspection fee (which is made up of the cost for conducting the inspection and a BBSQ administrative fee per unit of US\$40)"

4. Clause GCC 6.1 of the Special Conditions of the Contract is further amended by deleting the passage "*Service Provider will collect the inspection fee and pass to The Bahamas*"



Bureau of Standards and Quality, an amount per vehicle as administrative fee of 20.00 USD at the end of each month as agreed", and replacing the same with the following:

"Service Provider will collect the inspection fee and pass to The Bahamas Bureau of Standards and Quality, an amount per vehicle as administrative fee of 40.00 USD at the end of each month as agreed"



5. Section 1. General Conditions of Contract (A. General Provisions; 1.1. Definitions) is amended by adding the following:

"(v) "PVoC" means Pre verification of Conformity".



The rest of the provisions of the contract are still binding on both parties, save for the provisions specially amended by this Addendum No.1
